The COVID-19 vaccine is being distributed in a phased approach in order to allocate available vaccine supplies to priority populations in coherence with the Centers for Disease Control and Prevention (CDC) and the Advisory Committee on Immunization Practice (ACIP) recommendations and requirements. Dental Professionals are included in the 1A group per the state's guidelines, which also includes health care personnel and residents in long term care facilities. Additionally, some communities are beginning to vaccinate portions of the 1B group including firefighters and police along with adults 65 years and older.
