### Welcome

Dr. Gerlach welcomed all to the meeting and to 2023. Reviewed the agenda and not additional items were added to the agenda.

### **CHAW Updates**

Matt provided updates in the following areas:

- Staffing team is fully staffed at this point, Morgan Conti is returning from maternity leave. One area that Matt is focused on for 2023 is assessing the current needs of the team regarding staffing and support and will be evaluating the needs and structure of the team in early 2023.
- Funding no new funding updates but as a team we closed out 2022 in good shape not exceeding our budgeted losses allowed by Children's which is used for match purposes. We are focused in 2023 on seeking funding to support the ongoing work of our MDI program and to ensure we have the appropriate state support for 2023 and beyond. Finalizing an annual report in a new format to share with the board and others which will be completed by the Feb board meeting.
- Organizational updates internally there has been some reorganization and Children's is currently hiring an EVP and President for Child wellbeing that will oversee Bridget's area (CH&E), government relations and child wellbeing.
   Upon hiring of this role Bridget and our team will report up to this new role.
   Currently we will continue reporting up to Mark Rakowski.
- Board assessment updates completed doing 1 on 1 rounding with all board members and have gained renewed commitment from members knowing the role of being a connector, advocate and champion. A few members have decided for various reasons to step down from the board and we will honor them at a future board meeting.

### **Board Composition Committee Next Steps**

Moving into 2023 we will reconvene the board composition committee to discuss filling vacancies. Board input was that a smaller board (20-23) may be more desirable than being at previous numbers of 26-28 members.
