Welcome

Dr. Gerlach welcomed all to the meeting. Reviewed the agenda and no additional items were added to the agenda.

CHAW Updates

Matt provided updates in the following areas:

- Staffing – have hired new program manager (Sarah Kroening) for the EPA grant and in the process of posting for the administrative coordinator and meetings and conference coordinator roles that we will be splitting time with another one of the teams at Children's. Also in process of searching for a program manager for the injury prevention team as Marilyn Noll has retired.
- Funding – No funding updates, many initiatives are finishing grants that end in June and beginning to work on annual reports that are due and getting work plans and budgets in place for the new program cycle that begins in July.
- Organizational – down administrative staff but hope to be back to fully staffed this summer. Beginning to look at plans for a collaborative kids health summit to align with National kids health day in Oct 2024.

Board Composition Committee Next Steps

The EC reviewed and approved the outreach communication to potential board members. Matt will begin outreach to potential members that the executive council can review in August.

Advisory Board Meeting Planning

The June board meeting will be virtual and include updates from the executive director and an update from Alliance staff on the new EPA grant. Biosketch for Michael Kim

I am an academic pediatric emergency physician primarily focused on improving care to children in the setting of emergency department and prehospital arena as the co-chair of WI EMSC, pediatric medical director for ALS Consortium of Dane County EMS and UW Department of Emergency Section of EMS.

As the coinvestigator for a prehospital pediatric pain management grant, I was initially exposed to the EMS setting. Through two cycles of MCHB/EMSC targeted issues grant from 2004-2010, we developed a pain management module and dissemination to 3 other EMS agencies in the country.

American Family Children Hospital was built in 2006 and I was recruited in 2007 to develop an academic PEM program for the Department of Emergency Medicine and Pediatrics at the University of Wisconsin School of Medicine and Public Health. As the inaugural medical director and academic chief of the section until 2018, we recruited 4 additional faculty and developed a robust clinical program with pediatric nurses, child life specialists, dedicated pediatric rooms and 12 hours of daily PEM faculty coverage. Since then, we have grown to 13 room Peds ED, 24-hour child life specialist, and 7 fulltime faculty with 18 hours of coverage and continuing to grow.

As the chair of WI EMSC starting 2008, we were able to positively impact the emergency care of children in the state. Notable projects include funding and distribution of peds bags to all WI EMS agencies, provide pediatric emergency care conferences, creation and distribution of comfort bags, participation in the EIIC Pediatric Readiness Quality Collaborative, recipient of Advancing Healthier Wisconsin Grant for pediatric readiness initiative, recipient of EIIC Telehealth Grant, recipient of EIIC State Partnership Rural Expansion Program, recipient of EIIC PECCC grant, initiated a CQI program for the state in weight estimates in children and numerous educational presentations throughout the state. With the success in securing these grants over last 3 years, I feel that the work of WI EMSC has finally begun to make a meaningful impact for the state with much more yet to do.

In 2016, I was appointed as the pediatric medical director for the ALS Consortium of largest 5 EMS agencies in the Dane County. Since then, we have revamped the pediatric conference/education format, established pediatric case review process, advanced airway management protocol and established a QI program to improve weight estimate and medication dosing.

With this previous experience and leveraging the leadership positions, I am able to bidirectionally advance the emergency care at the local, county and state level that will impact the children of the whole state as the co-chair of the WI EMSC.
