Review and recommendation of new Advisory Board members

In an effort to continue our targeted recruitment for the Advisory Board, two individuals were brought forward for consideration as new members. Dr. Thao Nguyen is a general dentist with a passion for working with children. She is a full-time dentist at the Oneida Community Health Center, and also a part-time associate dentist at Young Smiles, a pediatric dental office in Manitowoc, as well as a volunteer dentist at the Northeast Wisconsin Technical College's dental assistant program clinic. Dr. Nguyen will be an asset to our oral health initiative. Dr. Andrea Swenson will replace Marsha Salzwedel as a representative from the National Farm Medicine Center in Marshfield. Dr. Swenson is a project scientist with the National Children's Center for Rural and Agricultural Health and Safety and focuses on program evaluation while researching the intersections between family dynamics, individual development and social environments.

A motion to recommend both individuals to the full Advisory Board for approval was made by Jay Shrader, second by Sandi Cihlar, and unanimously approved. Karen Ordinans will send the recommendation via email so the new members can participate in the next meeting.

Marsha will be sent the CHAW plaque and treats on behalf of the Board and staff thanking her for her service. Antonina also offered to send a note of gratitude on behalf of the Board.

Recognition of retiring Laura Rose

Nan Peterson provided words of congratulations and gratefulness to Laura Rose for her dedication to children's health and her time and efforts supporting CHAW.

Karen and Matt added their appreciation for all Laura has done for oral health. Laura received the CHAW plaque and treats in the mail and expressed her thanks for the opportunity to serve. She shared "Kids need strong advocates."

CHAW updates
