## What is the training about?

Trainers will provide valuable information on how to conduct a thorough death scene investigation, including utilization of doll reenactment. Attendees will gain a greater understanding of what information is important to medical examiners, coroners and law enforcement when investigating a child death.

## Why attend?

Wisconsin has built a comprehensive statewide system for the review of infant and child deaths in order to understand risk factors and inform prevention efforts. The child death review system relies on the multi-disciplinary structure of the review team and the expertise of team participants. Quality death scene investigations are critical to understanding the who, what, where and why of each child death. Doll reenactments are an investigation tool proven to aid in obtaining an accurate account of what happened.
