**Meeting minutes**

The minutes from the December 9, 2021 meeting were approved without any revisions or additions.

**CHAW Updates**

Matt updated the committee on staffing. A new communications coordinator should be on board by early February. New student from Carroll University will be starting in January.

The IDE statement reviewed by the EC at the last meeting was finalized and is on the "About Us" portion of the CHAW website.

The rules of operation and succession plan will be approved by the full board at the February meeting and then go through legal review at Children's.

**Board Engagement Update**
